- (iii) Chandigarh GST Zone-Amritsar & Ludhiana Cus (P) Commissionerate under Delhi Cus (P) Zone.
- (iv) Lucknow GST Zone-Lucknow Cus (P) Commissionerate under Patna Cus (P) Zone.
- (v) Ranchi GST Zone – Patna Cus(P) Zone Commissionerate and CCO of Patna Cus (P) Zone.
- (vi) Chennai GST Zone-Chennai Customs Zone, Trichy Cus (P) Zone & CCO of Trichy Cus (P) Zone.

4. The Pr. Chief Commissioners/Pr. Directors General/ Chief Commissioners/ Directors General concerned shall send the compliance report regarding relieving and joining of the above officers to the Board (with a copy endorsed to ADG (HRM-II), DGHRD) by 30.06.2022.

5. All the representations received till date regarding transfer and posting in the grades of Deputy/Assistant Commissioner of Customs and Indirect Taxes stand disposed of.
