

Fix accountability in PM's breach of security !

he lapse in Prime Minister Narendra Modi's security arrangements, which left his convoy stranded on a flyover for around 20 minutes, near Ferozepur in Punjab last month is indeed a serious one.

The constitution of a panel by the Supreme Court on PM's Security Breach is a welcome step. It has also done well to announce that there would be no "One-Sided Inquiry". Investigations into the security breach is being headed by a retired judge, Justice Indu Malhotra while officers of the National Investigation Agency (NIA) and the Punjab police are part of the inquiry which will inquire into what caused the breach, who was responsible and what safeguards are needed to prevent such lapses in future.

Over all charge of PM security is with SPG which has many prescribed layers. The pilot car guides the cavalcade. Normally the pilot car is 500 meters ahead of main PM cavalcade. Why pilot car did not sound. The area belonged to BSF. What were local police personnel deployed on that road doing. It seems too many hands lead to breach of this security or divided responsibility with no fixed accountability created this scenario.

The critical question that is that who made the decision that the Prime Minister could, and should, travel by road for more than 100 km, from Bathinda to Ferozepur and where and why the Punjab police and the intelligence agencies failed. This incident must also lead to a more efficient protocol for the Prime Minister's travel, and a repurposing of the Special Protection Group (SPG) which with an outlay of around Rs. 600 crore and around 3,000 personnel has just one job — protect one person, the Prime Minister.

The last time India's leadership failed to act on clear and present warnings of similar dysfunctions, a former prime minster was assassinated. That should be reason enough to be serious about finding out exactly what happened—and why.

India has paid a high price with the death of two Prime Ministers for lapses in security. A sitting Prime Minister, a former Prime Minister, and the leader revered as the father of the nation are among the list of the country's assassinated leaders.

The investigation thus needs to be done professionally and should identify and pinpoint the individuals or agencies who were responsible for the lapse.

Inland Waterways Transport Sector in India: An Overview:

Water transport is the oldest mode of transport even before the coming of railways. During start of 20th century, Inland Waterways Transport (IWT) was an integral part of transportation and widely used for trade and passenger movement. World over, IWT is recognized as a fuel efficient, cost effective and an environment friendly mode of transport, especially for bulk goods, hazardous goods and over dimensional cargo. With a waterways network of 14,500 km, India is endowed with various navigable IWT options which comprises rivers, canals, backwaters, creeks, and tidal inlets.

The Inland Waterways Authority of India (IWAI) came into existence in 1986 for development and regulation of inland waterways for shipping and navigation. The Authority primarily undertakes projects for development and maintenance of Inland Water Transport (IWT) infrastructure on national waterways.

Recognizing the benefits and importance of inland waterways and to increase it's modal share, the Government of India declared 106 new Waterways (NWs) through the National Act, 2016 taking the total number of NWs to 111. Out of these NWs, IWAI has identified 23 NWs for further development based on various technical-economic and commercial feasibility studies.

There are significant socio economic and environmental advantages of IWT over rail and road such as more load carrying capacity with less power consumption thus making it fuel efficient, least carbon emitting transport and negligible land requirement for development of IWT infrastructure. Though inherited with these benefits,IWT's share in the logistics sector in India remains very low at approx. 2% due to various reasons. One of the reasons has been the rapid development of other modes of transport i.e. rail, road and air, coupled with inadequate development and promotion of IWT sector over years responsible for the stagnation of the sector.

It is also important to understand some of the challenges faced by the sector and the impediments in its accelerated growth. One of the key issues faced by the sector is the management of the fairway both in terms of depth for navigation and the change of course of rivers caused due to frequent flooding and high siltation. The high silt loads lead to shoal formation and in many cases, cause splitting of the main channel. Thus, maintenance of navigational channels becomes a complex task due to large variation in discharge (where peak flows are very large and low flows very low), unstable morphological condition of bank and bed, heavy sediment load, continuous braiding, and meandering of the river.

Since 2014, renewed emphasis has been laid on development of IWT sector and Inland Waterway

Authority of India (IWAI) have made concerted efforts for seamlessly integrating IWT with other modes of transport. These include development of navigable channels and jetties, bank protection, construction of intermodal &multi-modal terminals along with navigational locks and their privatization, technological interventions for promoting ease of doing business, training & skill development programs and promotion of IWT to accelerate the development of Inland Waterways Sector in India. Through techno-feasibility studies, 23 of 111 notified National Waterways (NWs) have been identified to have the potential for movement of cargo, out of which 17 are currently operational.

Due to these interventions, the total cargo volume transported through operational NWs in India was 83.6 Million Metric Tonnes (MMT) in the year 2020-21 and has grown at a CAGR of 10.81% over the last four years. The traffic is planned to reach 120 MMT per annum by 2030. Predominantly, bulk commodities viz. coal & coke, iron ore, fly ash, limestone etc. are using the IWT mode in India and constitute more than 90% of the overall traffic. In addition, few movements carrying ODC (Over Dimensional Cargo), chemicals, stone chips, steel products and containerized cargo took place on National Waterways. Further potential exists for other commodities like cement, fertilizers, food grains and textile which IWAI is promoting among relevant industries.

IWAI has also developed a five year vision plan to achieve 2.5% modal share by 2030 which primarily includes strengthening regional connectivity through waterways with North East Region and neighboring countries, integration with coastal shipping and other modes, promoting supplementary use of waterways from targeted bulk and containerized cargo, promotion of passenger/cruise tourism and introduction of e-initiatives.

However, it is imperative that creation of infrastructure alone will not be enough for adoption and growth of IWT sector in India. Industry comprising shippers, vessel operators and allied logistics service providers needs to come forward and adopt IWT as a supplementary mode of transportation in their modal mix to support the cause of bringing down overall logistics costs in the country in a sustainable and environment friendly way.



President of India

President Ram Nath Kovind's five-year term comes to an end in July 2022, who will be new President of India. This time again the new President is going to be one of the state Governors may be SC or Tribal. Karnataka Governor Thawar Chand Gehlot is said to be ahead in the race followed by MP Governor Mangu Bhai Patel. One whisper says that present President Ram Nath Kovind may be given second term.

Ram Nath Kovind, serving as the 14th and current President since 2017 is the first person from Uttar Pradesh to serve on the coveted post. Prior to this, he has served as the 26th Governor of Bihar and as a Rajya Sabha MP. Prior to this, he practiced as a lawyer for 16 years and in the Delhi HC and the Supreme Court until 1993.



Vice President of India

Who will succeed Vice President Venkaiah Naidu this year ?.Grapevine says either Defence Minister Rajnath Singh or the BJP President J P Naddha may be picked up for this prestigious job.Other theory says that Karnataka Governor Thawar Chand Gehlot who was leader of the BJP in the Rajya Sabha may become the next Vice President. One can wait and watch.

Muppavarapu Venkaiah Naidu, serving as the 13th and current vice president since 2017, has previously served as the minister of Housing and Urban Poverty Alleviation, Urban Development and Information and Broadcasting in the Modi Cabinet. A prominent leader of the BJP, he served as its national president from 2002 to 2004.

Cabinet Secretary

Who will succeed Cabinet Secretary Rajiv Gauba in June ?.In case appointment of 1982 batch IAS officer Gauba is not made co-terminous in all probability Defence Secretary Ajoy Kumar may be appointed new Cabinet Secretary. 1985 batch IAS officer of Kerala cadre Ajay Kumar is scheduled to retire in October. Agewise Madhya Pradesh Chief Secretary Iqbal Singh Bains who has been empanelled to the rank of Secretary in GoI is senior to Ajay Kumar .He retires only in November 30.

The 1982-batch IAS officer of the Jharkhand cadre, Gauba, who was first appointed Cabinet Secretary w.e.f. Aug 30, 2019 with a tenure of two years has also been the Home Secretary besides Additional Secretary in the Home Ministry, looking after crucial left wing extremism division, among many other responsibilities.

Army Chief

Army Chief Gen M M Narvane is scheduled to demit office in April. Who will succeed him?. At present Lt Gen Manoj Pande - recently appointed Vice Chief of Army Staff – seems to be ahead in race. Lt General YK Joshi - Northern Army Commander and Lt Gen J S Nain - Southern Army Commander are also said to be other contenders for the post. If Pande is appointed, he would create history as there has never been an Army Chief from the Engineering branch. Lt Gen Nain is from the infantry.

General Manoj Mukund Naravane, PVSM AVSM SM VSM ADC, is Army General who is currently serving as the 27th Chief of the Army Staff since January 2020 as well as the temporary Chairman of the Chiefs of Staff Committee since December 15, 2021. 


R&AW Chief

Present Defence Secretary Ajay Kumar will retire in October end. 1987 batch Gujarat cadre IAS officer Raj Kumar with the wide experience as Secretary Defence Production may be brought back from Gujarat as Secretary Defence.

National Handicapped Finance and Development Corporation (NHFDC) was set up by the Ministry of Social Justice & Empowerment, Government of India in 24th January 1997. NHFDC provides concessional credit to Persons with Disabilities (PWDs) for starting any activity contributing directly or indirectly in the income generation or helping PwD in their overall process of empowerment and higher education through the State Channelising Agencies (SCAs) nominated by the State Government(s)/Public Sector Banks/Regional Rural Banks. The loan application is required to be submitted through the implementing agencies. The details of the Implementing Agencies in concern state may be obtained from NHFDC website.

Who can apply?

- 1. Any Indian citizen with 40% or more disability (Disability as defined in PwD Act, 2016 or its amendments).
- 2. Age above 18 years. However, in case of persons with mental retardation, the eligible age would be above 14 years. The age criteria would not be required for educational loans.

Area of Funding

- Starting any activity contributing directly or indirectly in the income generation or helping PwD in their overall process of empowerment.
- Pursuing higher education after class 12th (UG, PG, Professional courses and other courses approved by UGC/AICTE/ICAR/Government etc)
- Pursuing vocational or skill development (IT1, Diploma any other course leading to enhancement of employment or self employment)
- Purchase and/or fitment of any assistive device(s)/customization/retrofitting or conversion of available machine, equipment, vehicle to disabled friendly mode
